Infrastructure

The Southern Link Road (SLR), which will connect the A1 and A46 to the south of the town of Newark is currently under construction, it will open up development land and housing and will create

- ❖ 3000 jobs
- ❖ 2000 houses
- ❖ Improved access for the rail and road network

The area includes the development of a new single carriageway road with roundabout junctions along its length, a shared use footway at 6.44km of new road linking to the A1 and A45 and four toucan crossings

This is a key scheme in the delivery of Newark & Sherwood's Prosperity agenda. The project will bring the construction of houses, including affordable housing, two local centres including new retail opportunities, community and educational facilities, as well as providing a green infrastructure and a sustainable transport package which will link the site to Newark town centre

As a district there are many major benefits to our infrastructure which has opened up a great deal of land for employment and housing

- ❖ We have an improved rail service on the Castle Line (East-West)
- ❖ We work with East Coast Mainline to develop even better services (North-South)



- ❖ We are working to improve rural broadband and aiming for 100% connection as part of Nottingham and Nottinghamshire Devolution Deal with Government

Newark and Sherwood hosts a healthy mix of high profile businesses, innovative business with other major developments - Newark Academy, National Civil War Centre, new Leisure Centre and a new secondary school

Employment and Skills

Newark & Sherwood has a dedicated Employment & Skills Group offering recruitment support. This brings together delivery partners to support individuals who are out of work and help them secure suitable employment; assist employers with their recruitment and skills needs and link education with business to help improve our future workforce. When companies are looking to recruit staff we can support through liaising with all the relevant agencies and providing pre-recruitment training and first sift interviewing. This saves time and cost in the recruitment process. There is also funding available for Apprenticeships



The Apprenticeship AGE 16-24 Grant is a grant of £1500. If eligible a business can claim up to 5 grants. Eligibility Criteria includes commitment to employ for a minimum of 12 months or the time it takes to complete an apprenticeship and includes an agreement to pay the apprentice in line with legal minimum requirements

Think BIG and Pathfinder Loans

Think BIG and Pathfinder provides loans to existing, start up or early trading businesses that don't meet the banks' lending criteria but are able to demonstrate that they have a viable proposition for growth.

Think BIG: Available to existing small and medium-sized businesses in Newark & Sherwood with the ambition and potential to grow. As a guideline, we do not expect to provide loans to businesses with turnover of less than £150,000 or with fewer than 5 employees.

Pathfinder: Available to those who have a viable business plan with 2-3 years financial projections. Will employ at least 2 people and based in Newark and Sherwood.

Think BIG: As a guideline, loans are likely to range from £25,000 to £150,000

Pathfinder: As a guideline loans are likely to range from £5,000 to £25,000 (typically £5,000 to £10,000)

Repayments are made monthly, over a period ranging from 6 months to 3 years.

The interest rate charged will reflect the risk profile of the business, but will be around the commercial rate charged by the high street banks. There will also be a small arrangement and monitoring fee. Security may be required, depending on the risk profile of the business.

Tourism

With the growth of our local economy, tourism in the district is also flourishing. The opening of the National Civil War Centre in May 2015 has brought Newark in particular to national attention. Our excellent road and rail links ensure easy access to all that the district has to offer and places which appeal to all ages and tastes. Examples include Southwell Minster and Archbishop's Palace, Newark Castle and Air Museum, the National Trust Workhouse, Rufford Country Park, Sherwood Forest Visitor Centre and White Post Farm

There are also annual events such as the Newark Festival, Southwell Folk Festival and the Bramley Apple Festival, regular antique fairs at Newark Showground and racing fixtures throughout the year at Southwell Racecourse

Building Control

Our Building Control team is non-profit making organisation that prides itself in offering the most cost-effective, professional and customer focused service possible. All of our surveyors are highly experienced and have extensive local knowledge, which enables us to guide our customers from concept through to completion of building projects

We offer a friendly, efficient and accurate service, with fast turnaround on plan checking and same-day site inspections. We encourage involvement with customer projects at a very early stage to avoid construction omissions on site. We provide a free pre-application advice service prior to submitting your full application to resolve any design issues which may cause contraventions to the Building Regulations

We also offer a new telephone service for submitting building regulation applications and to quote one of our customers "it couldn't be easier". This facility enables you to submit applications over the telephone without forms or paperwork

Community Infrastructure Levy (CIL)

CIL is a tool for Local Authorities in England and Wales to help deliver infrastructure to support development of their area. It helps support strategic infrastructure such as schools and roads and to improve existing facilities. CIL will be used to fund strategic infrastructure within the district such as improvements to the highway network made necessary by the growth of the district up to 2026. Regulation 123 projects are funded by CIL

Most new development which creates net additional floor space or creates a new dwelling is potentially liable for the levy. Charges will be based on the size, type and location of the development proposed

To allow the Council to decide if your development is liable for CIL (and if so how much), an information form is available on our website. Please complete and submit with your planning application

CIL Amendment Regulations 2014 came into force on 23 February 2014. Applications for exemption for self-build residential development may be made to the council - subject to a number of criteria, if the development has not been started. Community group self-build projects qualify for the exemption where they meet the required criteria

Environmental Health

Newark and Sherwood District Council's Environmental Health and Licensing Service provides many functions that can have a significant impact on both residents and the business community. We provide public protection in relation to a wide range of environmental and health issues, such as air quality, noise, the food chain, and from businesses and rogue traders who unwittingly or deliberately breach acceptable standards set down in legislation. However, we recognise that as a business facing service, an important role is to support local businesses and boost local economic growth. This support is provided by helping businesses to understand and comply with controls and also by tackling rogue businesses that undermine reputable businesses and consumer confidence



Food Safety - We will provide advice and guidance on how to comply with food safety regulations for existing businesses and new business considering locating within the district

Contaminated Land - Land contamination enquiries often arise during the property conveyance process. The work detailed within our Contaminated Land Strategy has involved surveys and inspecting a wide range of documents, such as historical maps from the Ordnance Survey and council records on derelict land. We have obtained useful information on probable contaminative uses that have occurred across the district

We can supply a short search report which includes a summary of this information and a more detailed version. These are usually requested by developers or consultants with an interest in a site and its surroundings

Air Quality and Pollution Control - Some industrial activities could harm the environment or human health unless they are controlled. The Environmental Permitting Regulations 2010 introduced the latest system of environmental permits by integrating the previous Waste Management Licensing and Pollution Prevention and Control regimes. We will work with both new and existing businesses to provide advice and guidance to ensure emissions are kept within national standards

Licensing - The council is responsible for issuing a variety of licences, some of which you may need before you can start trading. Many of these are relevant if you have a business which involves selling alcohol or opening late in the evening such as pubs, restaurants and clubs. We also issue licences for other business purposes including taxis and professions which the Government states need to be licensed for safety reasons, such as beauty treatments and businesses involving animals

Rubbish and Recycling

Newark & Sherwood District Council (NSDC) currently operates a trade waste and recycling service, providing businesses throughout the Newark & Sherwood with an efficient way to recycle and dispose of their waste

The NSDC Trade Waste & Recycling Service provides businesses with wheeled containers suitable for dry, non-hazardous, light compactable waste; these bins are designed for businesses such as shops, offices, pubs, industrial units, small and large factory premises. There are 5 sizes of bin offered, ranging from a 2 wheeled plastic bin to a 4 wheeled metal bodied container (Sizes 140 litres to 1100 litres). Choosing the correct size of container helps to keep waste disposal costs to a minimum, and means you only pay for the waste you discard

Our Trade Waste & Recycling Service also offers a pre-paid waste label service for attaching to black bags of refuse. This service is used primarily by sites that have no space for a refuse bin



The Trade Waste Service also provides one off collections of bulky waste from businesses
If you operate any form of business, you have a legal responsibility under the Environmental Protection Act 1990 and other related legislation to safely contain and legally dispose of any waste produced from your business

Business Continuity; Preventing Disaster Ruining Your Business

Natural disasters, loss of key suppliers, malicious attack and other emergencies can affect any business; from the multi-national corporations to the small corner shop. However, there are ways in which such risks can be reduced. The role of Business Continuity Management (BCM) is to assist the continued operation of a business in the face of unexpected events and adversity - whether natural or man-made. In essence, Business Continuity is about planning and preparing for the worst.

Newark and Sherwood District Council (NSDC) is a Category One responder as defined by the Civil Contingencies Act and also a member of the Nottingham and Nottinghamshire Local Resilience Forum. Here, we work in close partnership with the emergency services and other responders to plan for and reduce the impact of major incidents.

The 'Nottinghamshire Prepared' website has links to both Business Continuity advice and the Community Risk Register. There are also links to Project ARGUS which is a free table top exercise delivered by the National Counter Terrorism Security Office (NaCTSO) based on the experiences of individuals and organisations before, during and after a terrorist attack

Registration of CCTV Cameras

There is a legal requirement for organisations that process and collect CCTV images, under the Data Protection Act, to register their premises with the Information Commissioner's Office (ICO).

Most organisations and businesses will be required to pay an annual notification fee of £35 and provide details about the types of personal information they process
