Presentation

1 Welcome

Cllr David Lloyd welcomed participants to the meeting.

- Covid-19 situation has been a focus for the Council but activity on the Towns Fund has continued with the intention to submit the Town Investment Plan by August.
- Data analysis and research has elucidated the 'challenges' for Newark and the resulting transformational projects for the Investment Plan.
- Sub-group meetings of the Board had taken place this week and considered potential propositions: thank you to participants for their contributions.
- Consultation and community engagement is a vital part of the process to shape the projects that will emerge.

2 Introduction

Tom Cartledge thanked the Council, Board and sub-group members for their efforts in progressing the Board's work.

Tangible projects are beginning to take shape; covid-19 impact means there is an increasing need for these to be transformational for the town.

Four key areas of work: Residential; Town Centre; Business and Education; Connectivity. [Slide 5 of presentation].

Residential

- Looking at sites to bring forward with a focus on increasing residential use in the town centre.
- Private sector investment is looking promising.

Town Centre

- Focus on culture and heritage and how this works with the town centre and traditional retail.
- The importance of the Market Place.

Business and Education

- Positive discussions with educational partners including Lincoln College Group, Aviation 360, Universities of Nottingham, Lincoln University and the YMCA.
- Focus is on improving the ambition for young people in Newark with a programme of vocational education at all levels as well as academic research and innovation.
- Opportunities with the Freeports at Immingham / Grimsby and East Midlands Airport.

Connectivity

Focus is on increasing use of transport alternatives to private car journeys. Improved connection between train stations, employment sites and town centre.

3 Sub-Group Meetings Update

Mike Wilson-MacCormack gave feedback from discussions at the three sub-group meetings held:

- Education, Business and Skills Monday 11th May
- Town Centre, Culture, Heritage Tuesday 12th May
- Infrastructure Wednesday 13th May

The sub-group meetings had been very positive and a valuable opportunity to share work so far and listen to feedback from participants. Thank you to the participants for engaging and contributing some great ideas; this will all be absorbed and translated into the proposals.

4 Next Steps

4.1 Matt Lamb outlined forthcoming activities and the timetable for the next phase of work including public consultation and engagement.

- Consultation will be carried out as an e-survey since due to covid-19 lockdown it has not been possible to carry out face-to-face consultation as had been hoped.
 - o Survey will be promoted widely via all forms of media
 - Live on-line in next week and will run for three weeks until 10th June. Link is here
 - Schools project including a writing competition for primary schools and a geography project for senior schools (later in planning)
 - Newark and Sherwood Community and Voluntary Services will be carrying out short telephone surveys and also delivering paper copies of the full survey via their networks and contacts
- Consultation with District and Local Councillors via workshops in May and June
- A second round of sub-group meetings week of 8th June for refinement of proposals
- There will be an additional Town Board on 26th June and Board of 10th July will sign off the Town Investment Plan in advance of NSDC Committee sign off.

4.2 Tom Cartledge emphasised that the Board is keen to involve everyone and listen to ideas and feedback, acknowledging that discussion and debate is not easy in on-line meetings and encouraging colleagues to get in touch if they want to discuss a particular aspect of the Board's work.

5 Further Comments

- John Robinson: the livestock market site has an EOI in the public domain for options including a possible relocation.
- Tony Aspbury: importance of a 'landing site' for visitors to Newark from where they can easily navigate to the town centre.
- Tom Cartledge: Post-covid challenges to the economy may present opportunities eg shopping centres losing tenants and looking for alternative uses or selling sites.

• Simon Witts: importance of finding a link and common themes between the sectors – eg STEM subjects in engaging young people and harnessing the Newark's manufacturing heritage.

6 Summing Up

Cllr David Lloyd thanked everyone for their contributions to the meeting. It had been a positive and open discussion. He emphasised that the Towns Fund is looking for projects which are truly transformation and which will make a gear change in the town. The work will continue to the timeframe outlined and will continue to engage people in greater depth.

Matt Lamb echoed Cllr Lloyd's thanks and appreciation for participants' contributions.
