1.0 Introduction

- 1.1 The Newark & Sherwood Community Infrastructure Levy (CIL) Charging Schedule was approved by Full Council on the 20th September 2011 and came into effect on the 1st December 2011. Planning applications decided on or after the 1st December 2011 may therefore be subject to CIL.
- 1.2 The District Council will use CIL to secure Strategic Infrastructure (as shown on the Regulation 123 list of Infrastructure) whilst Local Infrastructure will be secured through Planning Obligations in line with the Policies of the Core Strategy and the Allocations & Development Management DPD, utilising a Developer Contributions Supplementary Planning Document (SPD).
- 1.3 We define **Strategic Infrastructure** as improvements to the highway network which are required because of the growth of the District up to 2026, and which cannot be attributed to the development of any one site, and contributions to a secondary school where the location of growth requires additional secondary school provision.
- 1.4 We define **Local Infrastructure** as the development of facilities or services that are essential for development to take place on individual sites, and refers to the facilities or services that are essential for development to occur, or are needed to mitigate the impact of development at the site or neighbourhood level.
- 1.5 Regulation 62 of the CIL Regulations (as amended) requires a Charging Authority to:
- “Prepare a report for any financial year (“the reported year”) in which -*
- a) it collects CIL, or CIL is collected on its behalf; or*
- b) an amount of CIL collected by it or by another person on its behalf (whether in the reported year or any other) has not been spent.”*
- 1.6 The financial year to which this document relates is 2011/12 and the information within it relates to the period from 1st December 2011 (when the charging schedule came into effect) to 31st March 2012.

2.0 Monitoring

- 2.1 Table 1 on page 2 sets out the CIL Monitoring information as required by Regulation 62 (4).
