Thank for your message and update.

I've checked the new plan and can confirm that as Southwell Bridleway No.74 will now be along the edge of an open field. So long as the bridleway is not going to be enclosed by a fence or other boundary feature it is no longer necessary to include the condition we requested. There appears to be minimal physical impact to the bridleway apart from where the site access road crosses it.

With regard to the historic route to the east of the site. I have asked our Definitive Map colleagues at Nottinghamshire County Council to check the accuracy of the route and they or I will get back to you if there are any issues. I am a little confused about the southern end of the route as it seems to peter out on the revised plan.
