

Minutes of the Parish Council Meeting held on Thursday 5th May 2022 held in Walesby Village Hall

22/29 To confirm the minutes of previous Parish Council Meeting

22/30 Clerk's report on items from the previous meeting

- Clerk had not yet heard of any decision on the planning application for Haughton Way.
- Ground contractor has been instructed to go ahead with the clearing of plots 11 & 12.

22/36 To suspend standing orders for public participation

This item was moved in the agenda to allow the member of the public present to raise their point for discussion.

An allotment holder requested that a pile of rubbish was removed from his plot. Councillors agreed to this. Clerk to contact contractor to ask them to increase the skip size for the plot 11 & 12 clearing in order to remove this waste as well. Clerk was also asked to write to the allotment holders reminding them that it is their responsibility to keep their plots tidy and pointing out that if they don't and the Council have to arrange for them to be tidied up any costs will be passed on to the allotment holders.

The resident also made comment on the amount of speeding motorists around the village. The Councillors informed the resident that this is a constant complaint and that the Clerk is in regular contact with the Police and Highways although it they seem to come up with every excuse not to take any action.

22/32 To discuss the positioning of the dog bin on Kennedy Court

Clerk read out correspondence received from a resident on Kennedy Court requesting that the dog bin was relocated from its current position. In the correspondence the resident stated that they were away for a few weeks and would be following this matter up when they returned. The Councillors reiterated their belief that the position of the dog bin was fine which could be discussed with the resident if indeed they were in attendance at the next meeting.
