We have held two workshops since
May for residents to participate in. The
first workshop on 30th May looked at
Masterplan issues and options, and the
second on 27th June explored Playing
Field and Access. Feedback on the
workshops is overleaf.

the Bridge Community Centre.**

The plans and proposals that will
be shown at the Public Exhibition
are **for consultation purposes only**.



They currently include proposals for
demolition of some homes and the
development of new roads. These
proposals will be used for **discussion
and consultation with residents**
attending the Exhibition. The Council
will keep all residents up to date on
how the proposals develop, and will
provide information and advice for
those residents whose homes may
be most affected.

Resident Consultation in the Yorke Drive and Lincoln Road Playing Fields masterplanning:

The workshops help the project team to better understand the issues that are important to residents.

The Council wants to hear the views of the residents of Yorke Drive Estate about the proposals.

Workshop One – 30th May 2018, 6pm-8.30pm – Masterplan issues and options

Residents received a presentation on the Council's aims for the project, met the project team, and heard more about the resident consultation commitments and timetable. Working in small groups with members of the project team residents participated in discussions about:

- Their homes
- The roads and streets
- Routes and destinations

Feedback: 18 residents attended, with 14 completing voluntary feedback forms.

"I did not know what to expect, but I enjoyed being part of the debate and hearing from my neighbours. I was impressed with some of my neighbours too."



Workshop Two – 27th June 2018, 5.45pm – 8.30pm

Residents received a presentation on the project overview and the continued consultation process and timetable. Working again in groups they then looked at the current use of the Lincoln Road Playing field, provided ideas and suggestions on what they would like to see it used for and then discussed issues:

- Playing field use – current and future
- The possibility of building new homes on part of the playing field
- Opinions on access routes.

As part of this discussion residents were asked for opinions about new access routes and traffic calming measures.

Feedback: 49 residents attended, 14 stakeholders also attended.

The next Workshop on Wednesday 15th August, 5.45pm – 8.30pm, at the Bridge Community Centre, and will explore Homes in greater detail.

There is no need to book an appointment, if you live on Yorke Drive please just come along.
